Note 1: On February 17, 2017, Freemark Apparel Brands Inc., Freemark Apparel Brands USA Inc., Freemark Apparel Brands ESP Inc., Freemark Apparel TEC Inc. (collectively as the "Debtors") filed a Notice of Intention to Make a Proposal ("NOI") to its creditors and Richter Advisory Group Inc. was appointed Trustee.

On February 24, 2017, documents were sent by regular mail to all creditors of the Debtors, as identified by them, which included a copy of the Debtors' NOI, the whole as appears from the documents filed into the court records.

On March 16, 2017, April 27, 2017 and June 9, 2017, the Court granted extensions of time for the filing of a Proposal through to July 24, 2017 in order to allow the Debtors to implement certain restructuring initiatives, and subsequently to pursue and conclude a sales of the assets and business operations.

On July 24, 2017, the Debtors filed a Proposal in accordance with the Bankruptcy and Insolvency Act.

A Proposal was submitted by the Debtors at the meeting of creditors on August 14, 2017 and was duly accepted by the required majority of creditors. The said Proposal was ratified by the Court on August 21, 2017.

On September 5, 2017, the Trustee issued the Certificate of Full Performance of the Proposal.
