TO: CREDITORS OF CASTOR HOLDING LTD.

RE: Castor Holdings Ltd.

We are writing to you in our capacity as trustee (the “**Trustee**”) to the bankruptcy (the “**Estate**”) of Castor Holdings Ltd. (“**Castor** or the “**Bankrupt**”). On March 24, 2021 we had sent you a Reporting Letter for the purpose of providing you with an update, steps to complete, and timetable for completion. The following is to provide you with a further update as well as the steps remaining and estimated timing to finish this file. A copy of this Report also appears on the Trustee’s website (<https://www.richter.ca/insolvencycase/castor-holdings-ltd/>).

We had previously advised you that the Trustee’s administration is coming to a conclusion with the intention of the Trustee paying a nominal distribution to the Creditors (“**Dividend**”). The Dividend is a function of the remaining funds in the Estate trust account and the specific claims filed by Creditors and accepted by the Trustee. We had also advised that the delays in the finalization of the Trustee’s administration were not attributable to the Trustee, but rather as a result of uncontrollable external reasons (“**Events**”), such as government tax audits. Certain delays have continued and we now provide you with our revisions and comments on the various steps to conclude (“**Steps**”).

Remaining Trustee’s Administration

The following are the present remaining Steps prior to the payment of the Dividend:

1. The fiscal year-end of Castor is March 31. In conjunction with the Richter Tax Department, the March 31, 2021 year-end tax returns had been filed and accepted by the Governments. A final tax return shall be filed subsequent to March 31, 2022. The Trustee expects there to be no tax liability for year ended March 31, 2022 and therefore no ensuing delay in the issuance of the Dividend.
2. A penultimate Final Statement of Receipts and Disbursements (“**Penultimate Statement**”) as at July 31, 2021 had been approved by the Bankruptcy Estate Inspectors. This Penultimate Statement included the accrual of some legal bills which still required approval (“**Taxation**”) by the Québec Superior Court. The Taxation has been delayed which necessarily delays the preparation of the Final Statement which shall form the basis of the Final Dividend to be paid to creditors. It is expected that the Court hearing on the Taxation of the legal fees will take place on December 17, 2021. The corresponding judgement will either be rendered immediately or taken on deliberation; in the latter case there being a resultant delay at the discretion of the judge.
3. Upon the Court rendering its decision on the Taxation of the legal fees, the Trustee will then be able to proceed to the next sequential step as expeditiously as possible towards closure of this file. Namely, the Trustee shall prepare the revised Final Statement for Inspectors’ approval, and thereafter for submission to the Office of the Superintendent of Bankruptcy (“**OSB**”) for its comments.

4. Immediately upon receipt of the OSB comments, the Trustee will send the Final Statement to Québec Superior Court for Taxation ("**Court Approval**") but once again we reiterate that the Trustee does not control the timing of the decision of either the OSB or Court.
5. Upon receiving the Court Approval/Taxation, the Trustee shall send out the requisite legal Notice ("**Notice**") to the creditors that the Trustee intends to pay within approximately 60 days after the Notice, a Final Dividend to the creditors and to also advise the creditors that the Trustee will subsequently apply for its Discharge from the Court ("**Discharge**"). As mentioned in previous correspondence, the Discharge judgment essentially signifies the formal closure of the Estate file and liberates the Trustee of any future claims. If creditors and supplemental notified parties do not formally object to the Dividend Sheet, the Final Statement, or the Trustee's request for Discharge, then the "Timetable" can continue without disruption. **This means that the Payment would be issued to creditors in 2022.**

We reiterate our caution to you that the above sequential Steps and Timetable, as well as ensuing Payment, assume that there will be no further unforeseen Events. Should any Step not be completed on time, this would necessarily affect all subsequent Steps.

The Trustee shall, of course, advise creditors of any substantial delay in this Timetable.

We also remind you that the Castor Bankruptcy has been one of the most unusual in Canada, and therefore until the Trustee declares a Dividend and legal delays have expired with regard to the Trustee's request for Discharge, Events may arise causing further deferments and modification to the projected Dividend.

Statement of Receipts and Disbursements ("Statement")

The Trustee had some time ago provided you with a detailed Statement of the funds received and disbursed by the Trustee from July 9, 1992 to November 16, 2020. **A copy of the updated Penultimate Statement, projected Dividend sheet, and schedule of the latest known address of each creditor, are attached for your perusal and verification of your status. Should you observe any error or required modification, please immediately advise the Trustee.**

You shall, however, receive in due course the Trustee's Final Statement of Receipts and Disbursements ("Final Statement") together with a Notice of the forthcoming Dividend and date of the Trustee's request for its Discharge from the Court.

Should you have any questions, the undersigned remains available at your convenience.

Note 1 – Castor Holdings Ltd ("Castor"/"Estate") was declared bankrupt on July 9, 1992. The declared liabilities at that time were approximately \$1.8 billion. The declared assets allegedly exceeded \$1.3 billion. These assets included ownership of many subsidiaries dispersed throughout the world. After initial review by the Trustee, it was noted that the assets appeared to have been substantially overvalued with fraudulent representations having been made by management. Further, it was believed that Castor's auditors Coopers & Lybrand ("Coopers"), acted negligently in the issuance of their audit opinion. The Trustee on behalf of the Estate and a considerable group of creditors (the "Plaintiffs") commenced litigation against Coopers with regard to the negligence. These specific litigating creditors advanced loans to the Estate to assist in the prosecution of the litigation and are referred to herein and in correspondence as "Participating Creditors". The Trustee also took numerous legal actions against many other parties, including directors, officers, specific creditors, etc. It took until approximately 2011 for the Plaintiffs to receive favorable judgement against Coopers which was subsequently appealed to the Québec Court of Appeal who upheld the lower court judgement. Thereafter Coopers sought leave to appeal to the Supreme Court of Canada, but in 2015 the Supreme Court refused to hear Coopers' request for a further appeal. In response, Coopers sought protection under the Companies' Creditors Arrangement Act ("CCAA") and offered a settlement to the creditors who had sought judgement against them. The Trustee, being one of the original Plaintiffs, was a creditor in the CCAA proceedings. Ultimately, after much negotiation the creditors accepted the terms of settlement. The CCAA was only finalized in 2019. Thereafter, further delays ensued in the closing of the Castor Estate by the Trustee as a result of Provincial and subsequently Federal tax audits. The Federal tax audit was only concluded in March 2021.

The above is but a very succinct summary of that which transpired in the bankruptcy and some of the reasons for the extended delay in its finalization. For more details, you may refer to the Reports to Creditors which the Trustee has issued over the years, with the most recent Report dated March 24, 2021. These Reports appear on the website of the Trustee and can be found at: <https://www.richter.ca/insolvencycase/castor-holdings-ltd/>.

Note 2 – As can be seen from the Statement of Receipts and Disbursements ("Statement") the Trustee was obliged to use many legal firms to assist in the recovery of assets and in the various litigations. All legal fees have been approved by the Trustee, the Inspectors and the Québec Superior Court.

Due to the extended period of time for the Trustee to complete its administration it rendered numerous interim fee billings all of which have been approved by the Inspectors of the Estate. Additionally, the Trustee on 20 separate occasions informed the Superintendent of Bankruptcy Canada of the Trustee's intention to seek court approval of its fees ("Taxation") before the Québec Superior Court; each distinct Taxation being granted by the Court with the latest one dated April 23, 2021.

Note 3: -The Trustee had performed an extensive and detailed review of all proofs of claim received against the Estate. This review was rendered even more complicated in that many claimants had valid claims against certain of Castor's subsidiaries but not against Castor itself. After completion of this process and the issuance of disallowances by the Trustee, the amount of proofs of claim against the present Estate was reduced from approximately \$1.4 billion to approximately \$630 million, thereby effectively doubling the Dividend otherwise payable to the creditors.
