Take notice that:

1. On October 15, 2021, Junction Craft Brewing Inc. ("**Junction**") filed a Notice of Intention to Make a Proposal ("**NOI**") pursuant to section 50.4(1) of the *Bankruptcy and Insolvency Act* (Canada). During Junction's NOI proceedings, the Ontario Superior Court of Justice (Commercial List) approved, among other things, (i) the sale of Junction's business to 1000003059 Ontario Limited, a company controlled by certain of Junction's former shareholders, pursuant to a share purchase agreement dated November 5, 2021, and (ii) the incorporation of 1000054770 Ontario Inc. ("**ResidualCo**"), a wholly-owned subsidiary of Junction, for the purposes of accepting the transfer of certain assets (the "**Excluded Assets**") and liabilities (the "**Excluded Liabilities**") of Junction. Effective December 30, 2021, the Excluded Assets and the Excluded Liabilities were deemed to have vested in ResidualCo. Accordingly, all claims against Junction included in the Excluded Liabilities, are now, exclusively, claims against ResidualCo.
2. On December 30, 2021, ResidualCo filed an assignment in bankruptcy and Richter Advisory Group Inc. was appointed as trustee (the "**Trustee**") of ResidualCo's bankrupt estate by the Official Receiver, subject to affirmation by the creditors of the Trustee's appointment or substitution of another trustee by the creditors.
3. The first meeting of creditors of ResidualCo will be held on January 20, 2022 at 1:00 PM (the "**Meeting**"). As the Meeting is to be held remotely due to the COVID-19 pandemic, creditors who wish to attend the Meeting are required to complete the attached registration form and return it by email to the Trustee at the following email address: [claims@richter.ca](mailto:claims@richter.ca), no later than **5:00 PM (Toronto time) on January 19, 2022**.
4. Enclosed with this notice is (i) a condensed statement of assets and liabilities, including a list of creditors showing the amounts of their claims (as per ResidualCo's records), (ii) a form of proof of claim and proxy, and (iii) a registration form to participate in the Meeting.
5. To be entitled to vote at the Meeting, a creditor must file with the Trustee, before the Meeting, a proof of claim and, where necessary, a proxy.
