ENDORSEMENT OF JUSTICE CONWAY:

- [1] The Proposal Trustee has brought a motion seeking various relief, principally the annulment of the court-approved proposal. If granted, that would result in an automatic bankruptcy of the company.
- [2] Various stakeholders attended today to express their concerns about the company, how it was operated, and what information is available to them. In particular, Mr. Couwenberg, a Class B shareholder, told the court that he only obtained access to the Proposal Trustee's website last Friday. Ms. Cain expressed her concerns about the unpaid wages and payments owed to her.
- [3] Given the concerns raised today, and the consequences of annulling a proposal, I have adjourned this motion to **Friday, August 25, 2023 at noon for one hour before me**. That will give an opportunity for the Proposal Trustee and stakeholders to engage on these issues before the matter returns for adjudication.
- [4] The Proposal Trustee is not required to file another report.
