TRUSTEE'S FINAL STATEMENT OF RECEIPTS AND DISBURSEMENTS (concluded)

- Note 1: SMRT Labs Inc. ("SMRT" or the "Company") was a privately held company incorporated in June 2020 to develop and sell body temperature detection technology known as Thermal Pass to help mitigate the spread of the Covid-19 virus and other fever-bearing contagions. While there was early traction for ThermalPass units, changes in the global response to the pandemic, among other factors, negatively impacted interest in the Company's temperature screening system.
- Note 2: Despite the Company's determined sales efforts, the Company's financial performance suffered as interest in the ThermalPass units waned. On February 6, 2023 (the "Date of Bankruptcy"), SMRT made an assignment pursuant to the Bankruptcy and Insolvency Act (Canada) (the "BIA"). Richter Inc. ("Richter") was appointed as trustee (the "Trustee") of SMRT's bankrupt estate. The Trustee's appointment was affirmed at the first meeting of creditors held on February 24, 2023.
- **Note 3:** As at the Date of Bankruptcy, the Company's only asset was limited cash on deposit. The Trustee was informed that the Company does not have any patents or other intellectual property in respect of the ThermalPass technology due to various factors, including difficulty in appropriately classifying the device for registration purposes and related costs.
- **Note 4:** The activities of the Trustee since its appointment have primarily consisted of statutory work in accordance with the provisions of the BIA.
- Note 5: No Inspectors were appointed to this estate.
- Note 7: In consideration for consenting to act as Trustee in the SMRT bankruptcy proceedings, Commersive Solutions Inc. has provided funding to the Trustee (the "Third Party Funds") in the amount of \$30,000 to guarantee payment of the Trustee's fees and disbursement to the maximum amount of the Third Party Funds. Any shortfall to the estate will be borne by the Trustee.
