Re: CV-24-720816-00CL – Siena Lending Group Canada LLC (the “Lender”) and Global Food and Ingredients Inc., Global Food and Ingredients Ltd. and GFI Brands Inc. (collectively, “GFI”)

We are the lawyers for Richter Inc., the court-appointed Receiver (in such capacity, the “**Receiver**”) over GFI, in the Ontario court proceedings bearing court file number CV-24-00720816-00CL.

By Order of Justice Steele dated August 1, 2024 (the “**Distribution Order**”), the Receiver is authorized to make distributions to the Lender in respect of its secured claim against the ABL Priority Collateral, as defined in the Affidavit of James Simpson, affirmed May 23, 2024 (linked).

Pursuant to paragraph 5 of the Distribution Order, the Receiver hereby provides notice to the Service List that it intends to make a distribution to the Lender in the amount of upto \$500,000.00 on April 4, 2025 or later (the “**Proposed Distribution**”). The source of the Proposed Distribution is the realizations from the collection and settlement of GFI’s accounts receivables, and sale of GFI Ltd’s shares in Big Sky Milling Inc. The Proposed Distribution does not exceed the indebtedness owed by GFI to the Lender.

If no objection is received from any party on the Service List prior to **April 4, 2025**, the Proposed Distribution will be made without further delay.
