

**Notice and Statement of the Receiver**

The Receiver gives notice and declares that:

- On April 28, 2026 (the “**Appointment Date**”) pursuant to an order (the “**Receivership Order**”) of the Ontario Superior Court of Justice (Commercial List) (the “**Court**”), Richter Inc. (“**Richter**”) was appointed as receiver and manager (in such capacity, the “**Receiver**”) without security, of all the assets, undertakings and properties that as defined in the Receivership Order) (the “**Property**”) of Synaptive Medical Inc. (the “**Company**”) to exercise the powers and duties set out in the Receivership Order, pursuant to section 243(1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as amended (the “**BIA**”) and section 101 of the *Courts of Justice Act*, R.S.O 1990 c. C.43, as amended (the “**CJA**”). - The Receivership Order was granted pursuant to an application made by Export Development Canada (“**EDC**”) pursuant to security held by EDC in the Property of the Company, representing a charge of the assets of the Company.
- The Receiver took possession and control of the Property on April 28, 2026.

6. According to the Company's books and records, the amount owed by the Company to its unsecured creditors as at April 28, 2026, is approximately trade suppliers of \$6.5 million. The Company has approximately \$3.3 million in employee liabilities, of which, \$122,000 is estimated in respect of priority claims under section 81.4 of the BIA.
