**UPON THE APPLICATION** of ATTAbotics Inc. and ATTAbotics (US), Corp. (together, the "**Applicants**"); **AND UPON** reviewing the Affidavit of Mark Dickinson, sworn October 10, 2025; **AND UPON** noting that each of the Applicants filed a Notice of Intention to Make a Proposal under subsection 50.4(1) of the *Bankruptcy and Insolvency Act*, RSC 1985, c. B-3 (the "**BIA**") on July 2, 2025 (the "**NOI Proceedings**"); **AND UPON** noting that the time within which the Applicants are required to file a proposal in these NOI Proceedings was extended to October 30, 2025 (the "**Stay Period**") pursuant to the Order of the Honourable Justice Johnston,



granted September 8, 2025; **AND UPON** noting that by Approval and Vesting Order granted September 22, 2025, the Honourable Justice Gill approved the sale of substantially all of the assets of ATTAbotics to Lafayette Systems Canada ULC (the "Purchaser") and vested all of ATTAbotics' right, title and interest in and to the purchased assets in the Purchaser upon delivery of a Proposal Trustee's certificate (the "**Proposal Trustee's Closing Certificate**"); **AND UPON** hearing submissions by counsel for the Applicants and any other counsel present;

## IT IS HEREBY ORDERED THAT:

- 1. The Stay Period in these NOI Proceedings is hereby terminated upon the filing of the Proposal Trustee's Closing Certificate so as to result in the immediate and automatic assignment of the Applicants into bankruptcy pursuant to section 50.4(8) and/or 50.4(11) of the BIA.
