Take notice that on September 4, 2025, Richter was appointed as receiver (the "**Receiver**") of all of the assets, undertakings and properties (the "**Property**") of **Flow Beverage Corp., Flow Water Inc., Flow Beverages Inc., 2446692 Ontario Limited and Flow Glow Beverages Inc.** pursuant to an order (the "**Receivership Order**") from the Ontario Superior Court of Justice (Commercial List) (the "**Court**").

As you are likely aware, the Company announced that Flow and its subsidiaries entered into a support agreement (the "**Support Agreement**") with NFS Leasing Canada Inc. and RI Flow LLC (together, the "**Lenders**") whereby Flow's business assets are contemplated to be transitioned to the Lenders or their designee through a structured foreclosure (the "**Restructuring Transaction**"). The Lenders have agreed to fund the receivership proceedings while the Restructuring Transaction is implemented, which will permit the Company's business to operate in the ordinary course.

Please note that:

- During the receivership proceedings, under the supervision of the Receiver, the Company is continuing to carry on operations in the normal course;
- During these proceedings, the Receiver will work with the Company in connection with future purchase orders. Suppliers should continue to deal directly with the Company, however, through the supervision and confirmation of the Receiver;
- Pursuant to the Receivership Order, suppliers are required to continue to supply the Company with goods and/or services throughout the receivership proceedings; however, they are not required to extend credit to the Company; and
- Pursuant to the Receivership Order, the payment of all amounts owing by the Company to its creditors as at the date of the Receivership Order has been stayed.

At present, creditors are not required to file a proof of claim. The Receiver will provide you with further information should a claims process be commenced in the receivership proceedings.
